Community Access National Network

ANNUAL REPORT – 2015

The Community Access National Network (CANN) is a 501(c)(3) national nonprofit organization (formerly incorporated under the "Ryan White CARE Act Title II Community AIDS National Network") focusing on public policy issues relating to HIV/AIDS and Hepatitis C. Its coalition-based work is done on behalf of its patient advocacy groups, pharmaceutical partners and government agencies.

CANN's programmatic projects include:

- **National ADAP Working Group, or NAWG**
- **Hepatitis: Education, Advocacy, and Leadership, or HEAL**
- **HIV/HCV Co-Infection Watch**
- **Medicaid Watch**

National ADAP Working Group (NAWG)

NAWG brings members of the HIV/AIDS community and industry together to engage in conversation about the AIDS Drug Assistance Program (ADAP). This format was and still is extremely progressive since it takes into account all of the many different stakeholders to create a comprehensive view of the program and funding.

In 2015, NAWG published twenty-two (22) news distributions including information and updates on issues relevant to ADAP.

Hepatitis: Education, Advocacy & Leadership (HEAL)

HEAL raises awareness about Viral Hepatitis, and also educates consumers, community partners, and policy-makers about the fastest growing public health epidemic since AIDS: **HCV infection**.

In 2015, HEAL periodically hosted stakeholder meetings to discuss emerging issues. It published twenty (20) news distributions, including newsworthy articles on the latest testing, treatment, advocacy, and policy news. It published twenty-six (26) blogs – which are available online at <https://communityaccessnationalnetwork.wordpress.com> – as well as published an important infographic, "*Hepatitis C Therapies Covered by the AIDS Drug Assistance Programs*" (see page 3).

Programs include: 1) National ADAP Working Group ("NAWG), 2) Hepatitis: Education, Advocacy & Leadership ("HEAL")

Additionally, HEAL hosted (or co-hosted) the following events:

1. Congressional Briefing: High Out-of-Pocket Costs for Patients Living with HIV/AIDS and/or Viral Hepatitis.
2. HIV/HCV Co-Infection Free Pre-Conference Workshops.
3. Webinar on Harm Reduction #1: Syringe Exchange Service, Law Enforcement Relations and Legislative Advocacy.
4. Webinar on Harm Reduction #2: Overdose Prevention as an Engagement Tool for HIV & HCV.

HIV/HCV Co-Infection Watch

The HIV/HCV Co-Infection Watch is as a patient-centric informational portal serving three primary groups – patients, healthcare providers, and AIDS Service Organizations.

HCV infection is the most common chronic blood borne infection in the United States; approximately 3.2 million persons are chronically infected. Approximately 12,000 people die every year from HCV-related liver disease. The number of HCV-related deaths per year has outnumbered those dying from AIDS. It is estimated 200,000-300,000 people in the United States are co-infected with both HIV and HCV infections. Experts believe that about 25% of Americans with HIV also have HCV; conversely some 10% of people with HCV are thought to also have HIV. Without information, and access to comprehensive medical treatment, patients living with HIV and HCV infections are likely to progress to complicated liver diseases, such as cirrhosis of the liver, ultimately leading to liver failure and early death.

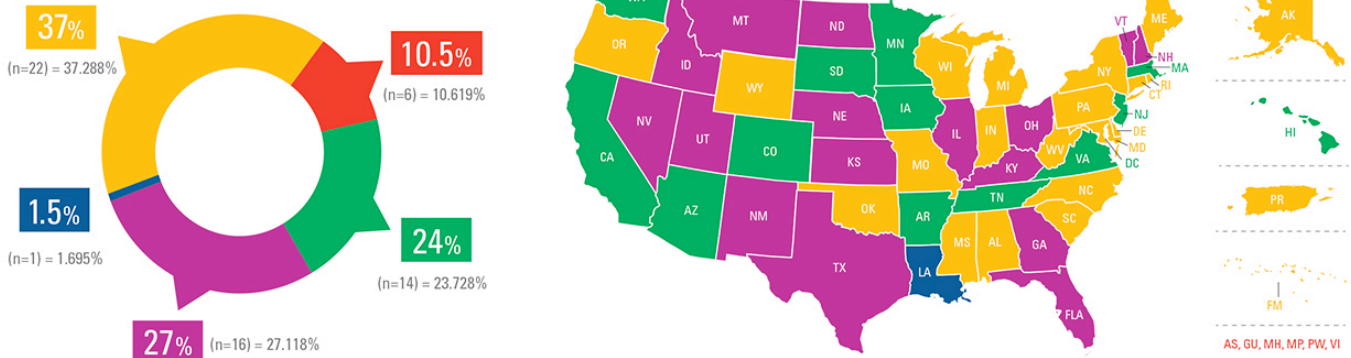


Medicaid Watch

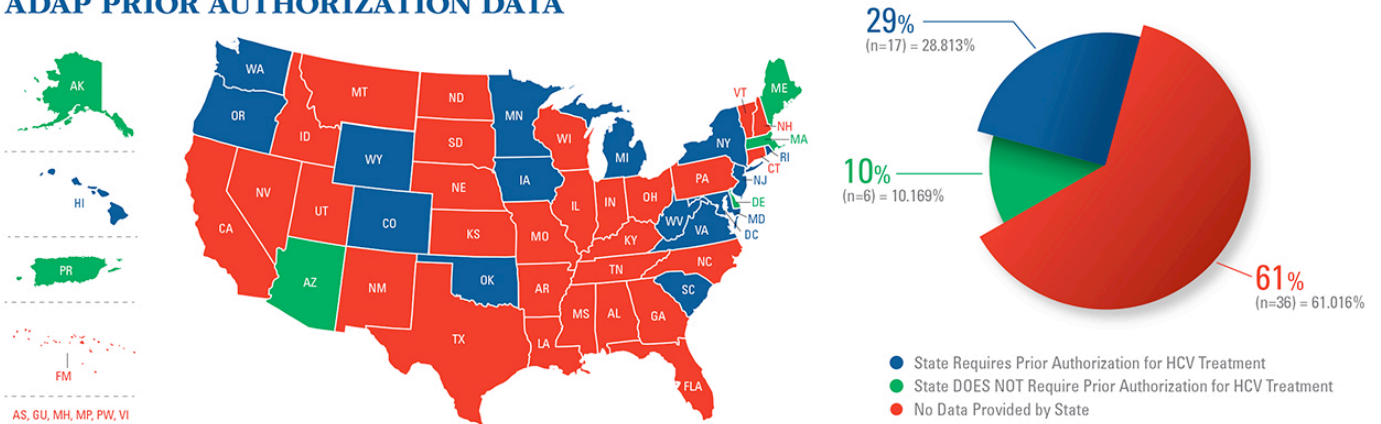
The Medicaid Watch monitors State Medicaid and healthcare spending cuts and expansions, as well as state-level Medicaid eligibility and access news. It also reports on other state health assistance programs, including: State Children's Health Insurance Programs (SCHIP); State Pharmacy Assistance Programs (SPAPs); and Safety-net hospitals offering free or discounted care to the indigent.

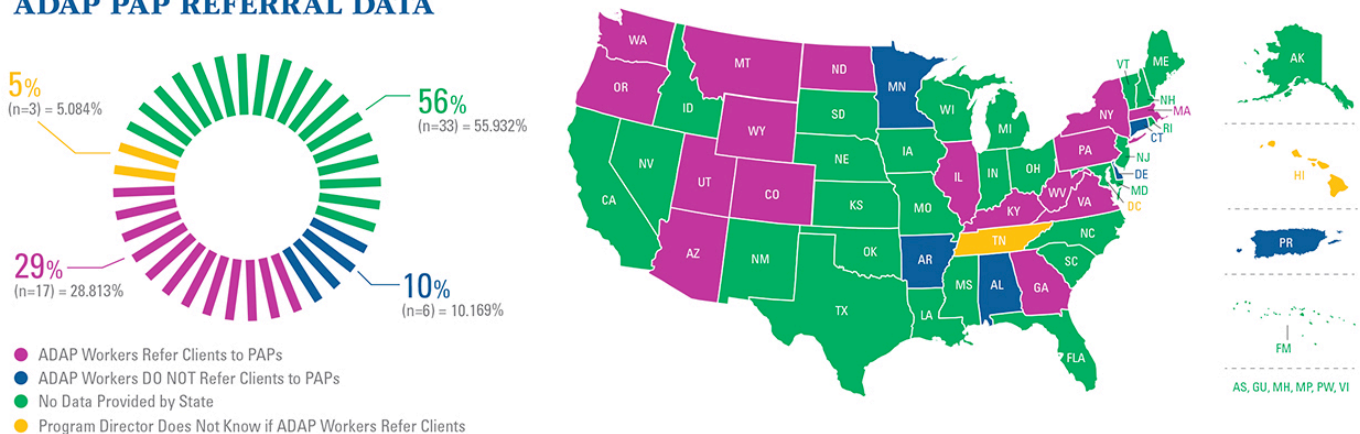
THE STATE OF COVERAGE FOR ADAP
